**DECLARATION OF AMANDA OSORIO**

I, Amanda Osorio, being duly sworn, deposes, and states as follows:

1. I am an attorney with Revision Legal, PLLC and familiar with the facts and allegations within Plaintiff's Complaint.
2. The Preliminary Injunction Order entered by this Court applied to all Defendants "including known and later identified defendant aliases" identified through discovery. ECF No. 25.
3. Plaintiff issued discovery requests on several service providers in relation to the original group of Defendants identified in Plaintiff's Complaint.
4. Through an investigation into the produced discovery, Plaintiff identified several other Defendant websites and online ecommerce stores that were infringing Plaintiff's trademark and copyright rights ("Additional Defendants").
5. On December 15, 2020 and December 23, 2020, Plaintiff served the Additional Defendants with a copy of the Summons, Complaint, and all other papers filed in this Court consistent with this Court's November 18, 2020 Temporary Restraining Order (ECF No. 19) approving service via email and internet publication. Specifically, I personally caused an email

to be sent to each email address associated with the Additional Defendants and published all relevant documents to a website under Plaintiff's control.

6. The Defaulting Defendants were served on November 25, 2020, December 15, 2020, and December 23, 2020.

7. The information relating to the infringement by each individual Defaulting Defendant identified in **Exhibit 1** is true and correct.

8. The Defaulting Defendants have failed to plead or otherwise defend.

9. Upon information and belief, the Defaulting Defendants are not active-duty members of the U.S. armed forces.

10. As a result, entry of Default against the Defaulting Defendants is proper pursuant to Fed. R. Civ. P. 55(a).
